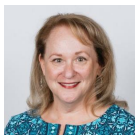

Liza has actively worked on a number of national and state initiatives around Social Security, Employment, Healthcare and Prevention. She has lead advocacy efforts in New Jersey for people with epilepsy on significant issues such as driving, education, employment, Danielle's Law, generic substitution and most recently non-medical switching and limiting out of pocket costs for medication. Her efforts lead to the establishment of an Epilepsy Task Force that was developed to make recommendations to the Governor on what is needed to educate the public and health
